

What is this Privacy Policy for?

This privacy policy is for this website www.interfoodtechnology.com and served by Interfood Technology Ltd and governs the privacy of its users who choose to use it.

The policy sets out the different areas where user privacy is concerned and outlines the obligations & requirements of the users, the website and website owners. Furthermore the way this website processes, stores and protects user data and information will also be detailed within this policy.

The Website

This website and its owners take a proactive approach to user privacy and ensure the necessary steps are taken to protect the privacy of its users throughout their visiting experience. This website complies with the GDPR, UK national law and requirements for user privacy and data collection.

Use of Cookies

This website uses cookies to better the users experience while visiting. Where applicable this website uses a cookie control system allowing the user, on their first visit to the website, to use cookies on their computer or device. By continuing to use <https://interfoodtechnology.com>, you are providing consent for cookies to be used. Users are advised that if they wish to deny the use and saving of cookies from this website on to their computers hard drive they should take necessary steps within their web browsers security settings to block all cookies from this website and any external serving vendors.

- (C) Notify Interfood immediately if it becomes aware of any loss of Personal Data or any breach by the Supplier or any of its Sub-Contractors.
